Verification of benefits & provider participation status is encouraged prior to services rendered

- PPO (Preferred Provider Organization)** - Broad network, various providers/ASC's/hospital systems participating, offers OON benefits
- OA (Open Access)** - Narrow network, limited providers/ASC's/hospital systems participating, referral not required, offers OON benefits
- HMO (Health Maintenance Organization)** - Narrow network, limited providers/ASC's/hospital systems participating, may require referral/authorization, usually offers INN benefits only
- EPO (Exclusive Provider Organization)** - Narrow network, exclusive providers/ASC's/hospital systems participating, referral/prior authorization usually not required, INN benefits only
- ACO (Accountable Care Organization)** - Group of doctors, hospitals, and other health care providers that work together to provide care
- CIN (Clinically Integrated Network)** - Independent providers sharing performance improvement, quality, value, and efficiency goals resulting in improved quality/coordinated care
- PHO (Physician Hospital Organization)** - Legal entity formed by hospitals and physicians allowing pursuance of common interests in a collaborative manner
